
YTD budget reviewed (through November 2015). Income is at 44.69% and expenses at 35.35%. No concerns noted at this time.

Discussion held in regards to changes with Iowa Medicaid. This program is now called Iowa Health Link. There are currently three MCOs that the state is contracted with to provide Medicaid services. Floyd County Public Health has signed with all three of the MCOs, have received a signed contract back from one MCO and have been in contact with the other two. Our contracts have been received and are still in the process of being reviewed. At this time Floyd County Public Health has been contacting

providers to see who they have signed with and are assisting patients with this transition process.
